Expanded Statewide Efforts to Contain the Spread of COVID-19

Since the mandatory facial covering policy was enacted in early July by Cincinnati City Council, we continue to see the R-factor (per person spread rate) decline in Hamilton and surrounding counties. And in recent days, we have begun to see an encouraging decline in inpatient cases at TriHealth – as of yesterday, just 32 COVID-19 positive patients. Given the strong evidence showing that maskwearing policies work to reduce the virus spread, Governor DeWine also issued a new statewide face covering mandate for all public areas, which took effect on July 23. This executive order is being supported by a new series of public service educational ads developed by the Ohio Bureau of Workers' Compensation. Click the screen to view one of the ads. New Eye Protection Protocols Go into Effect on August 3

As I shared last week, CDC has issued new guidance to healthcare providers on use of PPE to further protect healthcare workers from COVID-19 transmission. Accordingly, TriHealth, in collaboration with other area health systems, will be implementing new CDC-recommended eye protection safety measures. The new protocol will go into effect at TriHealth on Monday, August 3, and will require all clinical and non-clinical team members who have direct contact with patients to wear appropriate eye protection during every patient encounter. The eye protection will be provided by TriHealth and consists of disposable masks with built-in eye protection or reusable face shields, goggles or plexiglass screens. Personal eyeglasses are not considered protective eyewear because they lack the required side guards. The disposable eye protection must be discarded daily and the reusable eye protection must be cleaned at least once daily at the end of shift or when soiled. Isolation cleaning protocols must continue to be followed for all isolation patients, including COVID-19 positive or suspected patients. Complete details about the new eyewear protection protocols will be available through your leader and on Bridge later this week.
