

OFFICIAL RULES

TRIHEALTH CONCERT TICKETS SWEEPSTAKES

NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING VOID WHERE PROHIBITED BY LAW.

- 1. ELIGIBILITY:** The TRIHEALTH CONCERT TICKETS SWEEPSTAKES (“Sweepstakes”) will begin at 7:00 a.m. Eastern Standard Time (“EST”) on April 25, 2023, and end at 5:00 p.m. EST on May 2, 2023 (“Sweepstakes Period”). The time shall be determined by Sponsor’s timekeeping systems, and Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes. The Sweepstakes is open to: (i) legal residents of Ohio, Kentucky, and Indiana; (ii) who are 18 years of age or older and the age of majority in their jurisdiction of residence at the time of entry; and (iii) who are employed by TriHealth, Inc. (“Sponsor”) at the time of entry.

Sweepstakes is subject to all applicable federal, state, and local laws.

- 2. HOW TO ENTER:** To enter, visit <https://surveys.trihealth.com/trihealthconcertgiveaway> (the “Website”) during the Sweepstakes Period, locate the TRIHEALTH CONCERT TICKETS SWEEPSTAKES survey link, complete the TRIHEALTH CONCERT TICKETS SWEEPSTAKES survey and provide all required information (including name, TriHealth employee ID, and TriHealth email address) to receive one (1) entry into the Sweepstakes.

Limit: one (1) entry per person.

Sponsor is not responsible for lost, late, misdirected entries or entries not received regardless of cause. By entering and/or participating, entrants agree to be bound by these Official Rules and Sponsor’s Privacy Policy as set forth in these Official Rules.

You agree to reimburse Sponsor in full in respect of any losses, damages, and expenses, including reasonable legal fees (including, where permitted, reasonable attorney fees) that they may sustain from the breach of a representation or warranty made by you or the use of any rights granted by you to Sponsor hereunder. Potential winners will be announced at the May Team Member Town Hall meeting on May 10, 2023 at 12:00 p.m. EST. Potential winners will also be notified via email at the TriHealth email address provided on the potential winners' entry forms. If potential winner does not respond to the notification within a timely manner, as determined solely by Sponsor, Sponsor may conduct additional random drawings to select additional potential winners. As a condition of being named an official winner, winner must be able to access the digitally transferred tickets through a Trihealth email address to claim his/her prize within five (5) business days from notification of the transfer which shall occur one (1) week prior to the date of the concert or via the applicable concert promotor website/application. When claiming a prize, the winner must prove he or she is a qualified winner by presenting identification acceptable to Sponsor (e.g., state driver's license, state issued identification card; valid passport with address verification; or birth certificate with social security card and photo identification and address verification). If the winner cannot attend the selected concert date, or prove he or she is the qualified winner, another winner will be chosen from the remaining eligible entries received. Any unclaimed prize remains the property of Sponsor.
