- **Open seven new walk-in clinics inside area Walgreens stores** in early March that will conveniently serve our community members through our expanding TriHealth network of providers "in the moment" and "in their neighborhood" where they need and want care most.
- **Bring Blue Connection, our new insurance plan developed in partnership with Anthem Blue Cross, to employers throughout the greater Cincinnati region.** Doing so will further expand the impact we are making in improving the health of our community by providing more affordable access to high-quality healthcare coverage and increasing the number of patients under our care.
- **In January and February, open two new, major additions to TriHealth's already vast and unparalleled ambulatory network** – Thomas Center on the Bethesda North Hospital Campus and Liberty Ambulatory Campus.
- **Introduce TriHealthNow, our innovative new telehealth program, to TriHealth team members, area businesses, and the broader community.** TriHealthNow will give consumers immediate, remote access on their smart devices to TriHealth care when and where they need it, with backup support available as needed from Teladoc Health's national network of online board-certified physicians.
- **Set the bar for enriching the Living Wage in our community** by raising TriHealth's minimum wage to \$14 per hour in January, and then to \$15 per hour by the end of 2020.
- **Build stronger team member and physician awareness and understanding of Cultural Competency and Implicit Bias** through our Diversity, Equity, and Inclusion work in order to bring even better, more inclusive care and service to our diverse community.

Over the past few years, we've made great strides together in addressing the new realities of healthcare, pushing through our comfort zone, breaking down barriers, and challenging industry norms.
